# TERMS OF REFERENCE - RECRUITMENT AND ADMISSIONS COMMITTEE (R&AC)

# 1. Reporting

The Recruitment and Admissions Committee reports to the Senate.

## 2. Occurrence

The Committee should meet at least once each term. Special meetings may be called by the Chair of the Committee. The Committee shall use email circulation or telephone/video conferencing as appropriate to progress its business effectively.

## 3. Composition

The Committee membership consists of:

# 4. Terms of Office

No time restrictions apply for Committee members, but review should take place on a yearly basis to ensure fair representation and continuity of membership.

## 5. Attendance

At the discretion of the Chair other University officers, as may be appropriate, shall be invited to attend meetings.

# 6. Quorum

One third of the membership of the Committee will form a quorum.

# 7. Purpose

The purpose of the Recruitment and Admissions Committee is to oversee admission to the University and to develop policies for the University relating to the recruitment and admission of new students.

# 8. Terms of Reference

## 8.1 The duties of the Committee shall be:

- To develop strategies for the recruitment of students:
- To oversee admission to the University;
- To review the admissions policy and principles of admission on an annual basis to ensure that they enable the University to achieve its aims;
- To monitor the admission of students to ensure that the policy and principles of admissions are properly implemented;
- To ensure that Admissions Tutors are trained;
- To encourage consistency in admissions decision-making, and to ensure that this takes into account relevant student-related equal opportunities policies, e.g. disability, race equality;
- To review and develop policies and procedures relating to widening participation;
- To advise the Planning and Strategic Projects Unit, on setting University targets for the admission of new students and specific targets for each College/department within the University;
- To liaise with, and refer matters of interest to, other Senate Committees.

## 8.2 Other duties within their remit

- To receive the details of the award of Sporting and Music Entrance Scholarships
- To allocate strategically to Colleges/departments Postgraduate Taught Bursaries.
- To administer Undergraduate Entrance Scholarships
- To make recommendations to Senate on matters relating to the admission of new Students

# 8.3 Sub Committees/ Other Groups

## -Matriculation Panel

 To maintain and review matriculation requirements for undergraduate and postgraduate programmes;

- To consider and resolve all special cases not complying fully with the undergraduate (where appropriate) and postgraduate matriculation regulations;
- To resolve all questions of the interpretation of the matriculation regulations which require judgement on an academic matter;
- To resolve all other matters referred to it by the Academic Board and make recommendations regarding future changes to the Academic Board.

To consider any other matters referred to the Committee by Senate.

## 8.4 Effectiveness Review

To review annually the effectiveness of the Committee against its terms of reference and propose any recommendations for change to Senate.

## 8.5 Powers

- To act with authority delegated by Senate and included in their Terms of Reference;
- ii. To set up such task and finish groups as are necessary to expedite the Committee's business;
